### S.A. Resolution # 11 **Ex-Officio Bylaws Changes**

## 4 5 6 Sponsored by: Matthew Henderson '16

### Whereas, the current ex-officio designations are not currently specified as a collective unit in the Student Assembly Bylaws;

#### 7 8 9 Whereas, the Student Assembly Bylaws fail to clearly define ex-officio membership and 10 the reasoning for granting it, 11

- Be it therefore resolved, that Article I of the Student Assembly Bylaws be revised as 12 13 follows,
- Section 1: Ex-officio Membership 14
- Ex-officio membership grants members of the Cornell community (student, alumi, 15
- faculty, staff, administrator, etc.) full-debating privileges but not voting privileges. 16
- 17 These positions are granted to community members to either provide a perspective from
- 18 another governing body or to enhance the overall operations of the Student Assembly.
- 19 Section 2: Ex-Officio Executive Committee Positions
- 20 A. The SA can grant an ex-officio position to any member of the Cornell community 21 to serve as the Executive Archivist.
  - B. The SA can grant an ex-officio position to any member of the Cornell community to serve as the Parliamentarian.
- C. The SA can grant an ex-officio position to any undergraduate student to serve as 24 25 Director of Elections.
- Section 3: Organizational Liaisons 26
- 27 The SA will grant one member chosen by The Greek Tri-Councils an ex-officio A. 28 position as an organizational liaison. liaion status debating, but not voting 29 privileges. The liaison chosen by the Tri-Councils shall be selected on a rotating 30 basis from the three councils, beginning with a representative of InterFraternity 31 Council, following with Panhellenic Association, and finishing with Multicultural 32 Greek Letter Council.
- 33 The SA will grant one executive member from Residential Student Congress an B. 34 ex-officio position as an organizational liaison debating, but not voting privileges.
