

Resolution Approving Nominations to University Hearing and Review Boards

Whereas, the University Assembly (UA) is tasked to “select the members of the Hearing and Review Boards” per the UA Charter; and

Whereas, the Codes and Judicial Committee of the UA (CJC) has interviewed candidates for openings of student seats on the University Hearing and Review Boards; and

Whereas, the CJC has scored and ranked the candidates on a scale of 10 to 2 with 10 being the highest possible score and 2 being a recommendation to reject the candidate; and

Whereas, the CJC has ranked the candidates as follows:

Score of 10 (highest possible): Nicole Ackerman, Alexander Botkin, Brian Coard, Renae Curless, Michael Dalton, Chloe Gatta, Alyssa O'Connor, Isaac Todd, Anita Zhu

Score of 9: Ray Mensah, Jake Walter-Warner

Score of 8.5: Jamie Cohen, Kathleen Perkins

Score of 8: Delapo Emmanuel, Kierra Jones, Drew Singer

Score of 7: Haeyeon Yoon

Score of 6: Andrew Elkin, John-Paul Couce

Score of 5: Ulysses Smith

Score of 4: Lacey Steinel

Score of 3: Christopher Bando

Score of 2: Five candidates (names omitted) are not recommended for appointment

; and

Whereas, the CJC has unanimously resolved to fill any student openings on the boards with these candidates in accordance with the following priorities (in order of decreasing priority): (1) availability, (2) ranking/score, (3) in a manner consistent with maintaining a diverse and inclusive pool of board members, but only insofar as to break a tie between available and equally ranked/scored candidates; and

Whereas, the Office of Assemblies has yet to determine the number of current student openings for the pool of board members; and

Whereas, the Campus Code of Conduct (the Code) currently provides for twenty students to be among the pool of board members; and

Whereas, the CJC has unanimously voted to expand the number of student members in the pool

to twenty-five so as to increase the availability of pool members as a whole; and

Be it therefore resolved, that Title Two Article IV § C.1. of the Code be amended as follows, with additions in boldface and deletions lined-through:

The University Hearing Board and University Review Board pool shall comprise **55** ~~50~~ members confirmed by the University Assembly: **25** ~~20~~ students, 15 faculty members, and 15 nonfaculty employees. Faculty members are nominated by the Dean of the Faculty. For other candidates, the Office of the Assemblies will solicit written applications, and the Codes and Judicial Committee shall nominate candidates to the University Assembly for its confirmation no later than the last regular meeting of the outgoing University Assembly.

Be it further resolved, that any student openings on the board be filled in accordance with the herein described recommendations of the CJC.
